


# ENROLLMENT IN THE LITTLE ROCK SCHOOL DISTRICT Thirteen Year Comparison



The graphs below magnify the total, black, and white enrollment shown above. The graph above is at intervals of 5,000 students; those below are at intervals of 500.










#### ENROLLMENT IN THE LRSD AREA SCHOOLS Thirteen Year Comparison Prepared by the Office of Desegregation Monitoring


These graphs (which reflect the data on pages C-22 through C-32) show an enrollment increase in 1998-99 that resulted when the revised LRSD desegregation plan reclassified several district schools. The reclassification increased the 1998-99 enrollment in the area school category by the 2,530 students who attended Dunbar, Franklin, Garland, Mitchell, Rightsell, and Rockefeller, schools that previously had not been considered area schools.












# ENROLLMENT IN THE PULASKI COUNTY SPECIAL SCHOOL DISTRICT Thirteen Year Comparison












#### COUNTYWIDE ENROLLMENT TOTALS









#### 2000-01 Countywide Enrollment Comparison



# 2000-01 Countywide Black/White Enrollment Comparison



## Countywide Enrollment




The countywide enrollment, which is the combined enrollments of the LRSD, NLRSD, and PCSSD, is 52,969. The black-to-white proportion of this number is 4.6 points away from a 50%-50% ratio.

When comparing the enrollments of the LRSD and PCSSD, the black/white ratio is almost proportionally reversed, which has prevailed for many years. LRSD's enrollment is a little over two-thirds black, while PCSSD's enrollment is just below two-thirds white.
